
- MARNING: Important! Read and understand these instructions before installing or using the Locking Raised Toilet Seat. If you do not understand any part of these warnings, cautions or instructions, contact a healthcare professional for direction in the use of this product. If the raised toilet seat is not properly installed, personal injury and damage to the raised toilet seat could result.
- MARNING: If components are damaged or missing, contact your dealer immediately. DO NOT use substitute parts. Use only Lumex replacement parts. Non-Lumex replacement parts could cause personal injury and damage to the raised toilet seat.
- **⚠ WARNING: This product has a weight limit of 300 lb, EVENLY DISTRIBUTED.**


INTENDED USE

The raised toilet seat is intended for use by those who have difficulty sitting down on or standing up from the toilet.

INSTALLATION

- 1. Remove toilet seat from carton and protective packaging.
- 2. Lift lid and seat of toilet. This raised toilet seat fits most current, standard toilets.
- 3. Place raised toilet seat on toilet bowl rim, hooking rear flanges under rear edge of bowl. Ensure paddle is back far enough to clear inner rim of bowl. If not, turn knob counterclockwise.
- 4. Ensure the raised toilet seat rests flat on toilet bowl rim; straighten unit on bowl rim





Info: The adjustment knob head must be flush with the front of the toilet seat for proper fit. On smaller bowls, if paddle is moved to rear of its travel, the knob may pop out of its original position; the knob will automatically re-engage when you re-tighten. DO NOT force the knob to turn. If necessary, jiggle the knob a little to start the threads.

- 6. The raised toilet seat should now be securely installed on the toilet bowl. To ensure that you have a proper fit, intentionally shake the raised toilet seat to ensure proper placement and fit. The raised toilet seat should not move; if it does, re-install.
- MARNING: Ensure the raised toilet seat is installed as described. If the raised toilet seat is not properly assembled and installed, personal injury and damage to the raised toilet seat could result.

REMOVAL

- 1. Rotate knob counter-clockwise until raised toilet seat is free.
- 2. Lift front of raised toilet seat, then remove from toilet bowl.

OPERATION

- \triangle WARNING: Always ensure the raised toilet seat is securely installed before use.
- ★ WARNING: Users with limited physical capabilities should be supervised or assisted when using raised toilet seat.

MAINTENANCE / CLEANING

MARNING: Check the raised toilet seat weekly for signs of damage or cracking. If damage is found, DO NOT use the raised toilet seat. Contact your Lumex authorized distributor immediately.

Loosen, retighten, and check for secure fit of raised toilet seat weekly. To clean raised toilet seat, wash with soap and water or a mild household detergent and rinse with clear water. Ensure the raised toilet seat is rinsed well before use.

If moisture accumulates inside raised toilet seat, do the following:

- 1. Remove raised toilet seat from toilet bowl.
- 2. Turn raised toilet seat upside down and tilt toward drain opening.
- 3. Rotate until drain opening is facing downward and moisture drains from raised toilet seat.
- 4. Allow raised toilet seat to air dry for several hours.

▲ NOTICE: Never use abrasive cleaners or scouring pads on any part of the raised toilet seat.

LIMITED WARRANTY

SCOPE OF WARRANTY

Specific directions will be provided by the Customer Service Representative. Failure to abide by the specific directions will result in denial of the warranty claim.
